



# JUDICIARY OF SIERRA LEONE REQUEST FOR EXPRESSION OF INTEREST

#### PROVISION OF REPAIRS, MAINTENANCE, CLEANING AND WELDING

Dated: 2<sup>nd</sup> February, 2021

The Constitution of Sierra Leone Act No. 6 of 1991 establishes the Judiciary of Sierra Leone and vests Judicial power in the Judiciary of which the Chief Justice is the Head. In the exercise of Judicial power and with a view to delivering justice to its citizenry, the Judiciary operates specifically through the Supreme Court, the Court of Appeal and the High Court, as Superior Courts of Judicature and through the Magistrates Courts and the traditional Courts as Courts of Inferior Record. Other important bodies are the Judicial and Legal Service Commission (JLSC) and the Rules of Court Committee (RoCC)

With funding from the Government of Sierra Leone (GoSL), the Judiciary of Sierra Leone being an organ of Government, intends to apply part of its financial allocation on the provision of wide ranging operational services. It is in this regard that it now invites requests for Expression of Interest from reputable organisations so as to get them shortlisted for the provision of Repairs, Maintenance, IT Services and other services as detailed below:

- ✤ Generator Maintenance
- ✤ Air Condition Maintenance
- Photocopier / Printer Maintenance
- Vehicle Maintenance
- ✤ Welding of metal doors, gates etc.
- Building Refurbishment, Repairs and Maintenance
- Plumbing
- ✤ Bore Hole Maintenance
- Cleaning, Deep Cleaning, Garbage Collection and Fumigation

Established and registered enterprises providing the above listed Services are requested to express their interest in writing to the Judiciary.
